Photograph Consent Form

Dear Parents/Carers.

The school may take the decision to take photos of our pupils for various purposes. We may wish to use these images as part of our school displays and sometimes in other printed publications or on our school website, and Twitter account. We may also include photographs in Learning Journeys and Seesaw accounts that record your child's progress throughout school and these may include photographs of individuals, groups or classes of children.

Occasionally members of the media may visit our school to report events and to take images or video. Children may appear in these images, which will sometimes be published in local or national newspapers, or on approved websites. To comply with Data Protection requirements, we need your permission before we can photograph or make any recordings of your child. This form is designed to allow you to register your consent to the use of photographs in certain situations and you are free to decide how and when any images of your child may be used. We will not use any images of children where we do not have parental consent.

Where a parent fails to return a photo consent form we will assume consent has not been given.

Conditions of use:

In ensuring that we always use photographs in an appropriate and responsible fashion, we will ensure that:

- 1. You can withdraw your consent for the use of the images at any time by contacting the school's Data Protection Officer details below.
- 2. The images we take will be of activities that show the school and children in a positive light.
- 3. Embarrassing or distressing images will not be used. The images will not be associated with negative or sensitive issues.
- 4. We may use group or class photographs or footage with very general labels e.g. 'science lesson'.
- 5. We will only use images of pupils who are suitably dressed.
- 6. We will make every effort to ensure that we do not allow images to be taken of any children for whom we do not have permission or who are 'at risk' or disallowed from having their photographs taken for legal or social reasons.
- 7. We will take all reasonable measures to ensure the images are used solely for the purposes for which they are intended. However we cannot guarantee this and take no responsibility for the way images are used by other websites or publishers or for any consequences arising from publication.
- 8. Historic photographs will remain on our school website and social media feeds. We will not use the personal details or full names (which means first name and surname) of any child or adult in a photographic image or video, on our website, on our social media platforms in our school prospectus or in any of our other printed publications.
- 9. If we use photographs of individual pupils, we will not use the name of that child in the accompanying text or photo caption.
- 10. If we name a pupil in the text, we will not use an individual photograph of that child to accompany the article.
- 11. We may use group, team or class photographs or footage with very general labels, such as 'a science lesson' or 'making Christmas decorations'.
- 12. If a child has won an award or been honoured in some way and we would like the name of their child to accompany their picture we will obtain permission from the parent before using the image.

Please confirm that you have read and understood the conditions detailed above and that you understand that:

This form is valid for the period of time your child attends this school. Images of your child will not be used after this time. We will not re-use any photographs or recordings after your child leaves this school but images may remain on school websites and social media feeds in an 'historical' context.
